The meeting was held on Tuesday, October 6<sup>th</sup>, 2015 at Broadway Housing, 583 Riverside Drive, New York, NY 10031.

Chair, Rev. Georgiette Morgan-Thomas called the meeting to order 11:30 a.m. and welcomed everyone. She reported that Access-A-ride was scheduled to present, but didn't show or call to cancel.

#### Reports:

#### Independence Care System:

Mr. Danny Perry, Director of Community Management and stated that his agency is a community-based, non for profit serving the Bronx, Brooklyn, Manhattan and Queens. It is dedicated to supporting senior adults with physical disabilities and chronic condition to live at home and participate fully in community life. The agency offers two distinct plans:

- i. **Community Care MLTC Services**: a traditional Medicaid managed long-term plan. This plan includes dental care, eye exams, medical supplies, physical therapy, and transportation.
- ii. **Community Care Plus FIDA-MMP Services:** it is a plan for recipients of both Medicaid and Medicare who reside in the four boroughs of New York City, Bronx, Brooklyn, Manhattan and Queens. The plan is designed to customize and coordinate a full range of home care, health care, and social services. The goal is to keep clients healthy, safe and independent.

Medicaid Surplus pooled trust account offers a safe and legal alternative that allows recipients to keep their surplus and better control their funds. The New York State Medicaid Program sets the limit based on the number of members in the family and if the income is above the required limit, Medicaid considers it as excess income and often referred to as 'surplus'. As a recipient of Medicaid any surplus income by law the recipient is required to give the money to Medicaid or use it to pay medical expensed in order to stay in the Medicaid Program. A Medicaid recipient can choose to enroll in a pooled trust account, and can utilize the funds for a variety of needs, such as paying rent, utilities, cable, groceries, clothing, personal care, traveling etc. A Medicaid recipient enrolled in a pooled trust, Medicaid will continue to pay for homecare and other long-term care services. If one has a surplus and is not enrolled with the pooled trust account Medicaid requires one to give the entire surplus to the health plan to assist in paying for one's medical expenses; otherwise one lose their Medicaid eligibility.

### The New York City Department For The Aging:

Verna Arthur, Community Outreach Director reported that DFTA just had budget consultation and on October 26<sup>th</sup>, 2015 there will be public hearing and seniors are invited to participate; bring all their concerns and needs. Encouraged seniors to send someone on their behalf or send a written statement to the Commissioner.

### The George Bruce Library:

Ms. Junelle Carter-Bowman, Library Manager stated that computers have been updated and computer training program will resume from basic computer skills to a customized computer training program. The senior computer program is still available and seniors are welcome to register. The library has added board games and movies to their programs.
