

## November, 2016 District Manager's Report

### FDNY

#### Reported:

On 10/20/2016 @ 1:12 AM, a 2 alarm fire occurred at 605 W 141 St, a 6 story Occupied Multiple Dwelling Building. There was a Structural Fire located on the 6<sup>th</sup> Floor, upon arrival units found fire in apartment. Engine companies stretched and operated four hand lines. Ladder companies performed vent, entry, search and overhaul. Units were unable to determine the cause of the fire and requested the response of the fire marshal for investigation.

The FDNY responded with the following apparatus and equipment

There were 5 firefighters and 1 civilian injured.

The fire was placed under control at 2:32 AM.

Reported on the importance of Smoke Alarms, and stated most fire deaths occur in the middle of the night. A smoke alarm is the single most valuable lifesaving device you can have in a home. Smoke alarms are designed to detect and warn that silent, but deadly smoke is in the air. (See attached Flyer)

- Shooting occurred the end of October at 133<sup>rd</sup> St. & Amsterdam Ave.; victim struck in torso and leg;

- Robberies down with a pattern on 10/11/16 victim was dropped off at school and headed towards store on Amsterdam Ave. victim was approached by an individual with gun, it was reported cell phone was stolen. Apparatus has been deployed on Amsterdam Ave.
- 50% of stolen property is due to unattended property, Crime Prevention Officer Clifford regularly attends events/lectures on Crime Prevention and how to safeguard your valuables;

### **26<sup>th</sup> Pct. (Crime Prevention) Reported:**

Deception Burglaries (The Scam) Criminals often target elderly victims, and operate during normal business hours (9am-5pm), making them less likely to question the situation. These impersonators use false covers such as; utility companies, delivery companies, and companies such as plumbing or electrical contractors. A common ploy being used is: "A pipe broke down the block and we have to check the water". Once inside, the perpetrator(s) manipulate the distracted victim while pocketing their valuables;

Green Dot Card Scam People are losing thousands of dollars in a phone scam involving Green Dot Money Pak cards. After receiving a call from someone who claims to be collecting the debt from either a Utility Company, the IRS or as a settlement for an auto incident; people are being threatened with the loss of their heat, electric, possible deportation or criminal prosecution.

Three typical scenarios:

**IRS Scam** – A caller informs the victim that they owe back taxes to the IRS and must make immediate payment with a Green Dot Money-Pak;

**Accident Scam** – The victim's family member had a car accident and the caller threatens physical violence unless immediate reimbursement is made with a Green Dot Money-Pak;

**Utility Scam** – Utility companies demand immediate payment by Green Dot Money-Pak or your electricity or gas will be turned off

## Manhattan District Attorney’s Office

### Reported:

On the importance of Domestic Violence Awareness, and bringing this issue to the forefront by raising awareness. The Domestic Violence campaign also continued with discussions throughout the district including Manhattan Community Board No. 9’s General Board Meeting held on Thursday, October 20<sup>th</sup>.

Manhattan District Attorney Cyrus R. Vance, Jr., recently released a report on the Manhattan District Attorney’s Office’s Domestic Violence Initiative, compiled with input from dozens of city agencies, community-based organizations, and experts over the course of two-year collaboration. District Attorney Vance announced funding for multiple initiatives recommended within the report, including a pilot program to equip the Manhattan Family Justice and Child Advocacy Centers with “Alternative Light Source” technology, including handheld devices that enable the user to better see bruising and other injuries, particularly on dark skin tones. The Manhattan District Attorney’s Office will also be equipped with a dedicated camera capable of taking infrared photographs to better document these injuries, which are not always visible to the naked eye. Other report recommendations being funded by the District Attorney’s Office include \$1.4 million for the creation of Abusive Partner Intervention Programs, as well as \$11.4 million for programs that broaden access to services for victims of crime.

\$19M in funding available to divert low-level Offenders from the Justice System, develop Social Enterprises to employ the formerly incarcerated and at-risk New Yorkers, and support Youth Aging out of the Foster Care System. Manhattan District Attorney Cyrus R. Vance, Jr., announced three significant investments aimed at preventing crime and reforming the justice system, including new funding opportunities for: early diversion programs for low-level

misdemeanor offenders; social enterprises for young people and formerly incarcerated individuals; and innovative transition programs for youth who are transitioning out of foster care.

### ***Early Diversion Programs***

The District Attorney's Office is seeking proposals to create early diversion programs that take place after arrest and before arraignment for eligible New Yorkers of all ages that are issued a Desk Appearance Ticket (DAT) by the Police for low-level offenses. Early diversion programs will provide participants with opportunities to avoid prosecution and an arrest record, and be connected to service providers in the community – while being held accountable for their misdemeanor offense in a community setting.

Investment in early diversion enhances public safety and accelerates reform in the justice system by providing more effective, community-based responses that hold offenders accountable and provide opportunities for positive development. This approach also conserves intensive and expensive court responses for more serious criminal cases.

Applicants are invited to submit proposals for programs specifically tailored to young adults, or for programs applicable to the entire adult population. The District Attorney's Office will provide total funding of up to \$6.5 million over three-and-one-half years. Diversion programs being funded under this RFP are expected to serve more than 8,500 New Yorkers.

### ***Social Enterprises***

The DA's Office is also seeking proposals to create "social enterprise" employment opportunities for at-risk youth and formerly incarcerated New York's (first ever of such funding) the opportunity from a criminal justice agency in the U.S.

Social enterprises are non-profit organizations (or non-profit divisions of for-profit entities) which blend the social welfare mission of a non-profit organization with the market-driven approach of a business. Under this RFP developed in collaboration with the NYC Economic Develop Corporation (EDC) up to \$7.3 million will be made available to fund social enterprises which: (i) provide meaningful training and career opportunities to young people at elevated risk or justice-system involvement as well as formerly incarcerated New Yorkers reentering their communities; and (ii) generate a positive economic impact in underserved New York City neighborhoods.

Applicants are invited to propose new enterprises, or to scale up existing enterprises. The District Attorney's Office will fund up to four social enterprise programs, with \$7.3 million in aggregate funding available over three-and-one-half years.

### ***Youth Aging out of Foster Care***

Finally, the District Attorney's Office is seeking proposals developed in collaboration with the New York City administration for Children's Services (ACS) to provide educational, employment, and housing services to youth aged between 16 and 24 who are "aging out" of New

York City's foster care system. In 2015, 616 young New Yorker "aged out" of the foster care system without being adopted or returned to the custody of a parent or guardian. Funding will be made available to proposals which support this population's educational attainment, workforce development, and housing permanency.

Many young people involved in the foster care system are at increased risk of involvement with the criminal justice system. Foster youth face higher rates of incarceration than the general population. A 2015-Study focused on a group of young New Yorkers who were discharged from foster care between the ages of 13 and 18 found that 15 percent were incarcerated within six years. Of the foster youth who aged out of the NYC child welfare system in the mid -2000's one in ten entered a homeless shelter within one year, and one in five entered a shelter within three years. Investments in remedial education and pathways to employment best equip this population to transition out of care successfully.

Additionally, the Manhattan District Attorney's Office has invested: \$7.5 million to pay for college programming at New York State prisons; \$90million to equip the NYPD with tablets, handheld devices, and mobile databases for every police officer and patrol car; \$101 million for critical NYCHA security upgrades, including cameras, lighting and keyless access; \$38 million to help end the national backlog of untested rape kits; \$40million towards the City's comprehensive mental health initiatives, including \$14 million for supervised release for eligible defendants pre-trial; \$25 million to form the cross-border, cross-sector, not-for-profit Global Cyber Alliance; \$7.5 million to expand Saturday Night Lights, the District Attorney's Office's signature youth violence prevention initiative operating in 14 locations across Manhattan.

Applicants are invited to submit proposals for new or newly expanded programs that provide educational, employment, and housing services to youth aged between 16 and 24 who are transitioning out of New York City's foster care system. The District Attorney's Office will provide \$5.3 million over three-and-one-half years under this RFP. **Reported:**

Tenants of 1351 Amsterdam Ave. (Grant Housing) recently had their gas restored; awaiting NYCHA's completion of ground excavation and other required work at 75 LaSalle Street before service are restored. Con Edison reiterated that they cannot continue the gas restoration process without NYCHA first completing their external and internal building repairs. ConEdison's goal is to restore gas as quickly as possible but unfortunately it will take additional time.



## **Department of Health and Mental Hygiene**

### **Reported:**

Sexual and reproductive justice (SRJ) exists when all people have the power and resources to make healthy decisions about their bodies, sexuality and reproduction. SRJ means that every person has the human right to:

- Choose to have or not have children;
- Choose the conditions under which to give birth or create a family;
- Care for their children with the necessary social support in a safe and healthy environment;
- Control their own body and self-expression, free from any form of sexual or reproductive oppression;

The term "reproductive justice" was coined by a group of black women in 1994. From this group, a framework and Sister Song, a collective led by indigenous women and women of color, emerged.

### **What is the SRJ Community Engagement Group?**

The SRJ Community Engagement Group (CEG) is a group of community leaders, activists and nonprofit organizations that work with the support of the NYC Health Department to promote SRJ in New York City. The CEG meets monthly to plan and implement activities so that all New Yorkers can safely express their sexuality and gender identity with dignity, and have the knowledge, skills and resources to lead healthy and fulfilling lives.

### ***Mental Health First Aid:***

As part of the Thrive NYC initiative, the NYC Department of Health and Mental Hygiene are offering free Mental Health First Aid training to all New Yorkers. Mental Health First Aid (MHFA) is a groundbreaking public education program that teaches the skills needed to identify, understand, and respond to signs of mental health and substance use challenges or crises.

Research shows that Mental Health First Aid leads to:

- Greater recognition of behavioral health challenges

- Increased confidence in one's ability to help
- Increased amount of help provided
- Decreased stigmatizing attitudes while promoting inclusion

Adult and Youth MHFA courses are offered on a regular basis at NYC DOHMH.

## **Certification Programs**

### **Adult Certification**

Adult Mental Health First Aid is appropriate for adults 18 years and older who want to learn how to help a person who may be experiencing a mental health related crisis or problem. The course teaches participants a five-step action plan to support someone developing signs and symptoms of a mental illness or in an emotional crisis. Topics covered include: anxiety, depression, psychosis, and substance use disorders. The adult course is available in both English and Spanish. Course participants come from a variety of backgrounds and play various roles in a community.

### **Youth Certification**

Youth Mental Health First Aid is designed to teach adults who regularly interact with adolescents such as parents, family members, caregivers, teachers, school staff, peers, neighbors, health and human services workers, and other caring individuals how to help an adolescent (age 12-18) who is experiencing a mental health or substance use issue or is in crisis. Youth Mental Health First Aid is primarily designed for adults who regularly interact with young people. The course introduces common mental health challenges for youth, reviews typical adolescent development, and teaches a 5-step action plan for how to help young people in both crisis and non-crisis situations. Topics covered include anxiety, depression, substance use, disorders in which psychosis may occur, and disruptive behavior disorders.

In addition to the Adult and Youth certifications, you can also request training for your organization in the following modules: Veterans and Military Families, Higher Education, Older Adults, and Public Safety (descriptions below). If you would like to request MHFA training specifically for your organization, please click on the following link.

### **Public Safety Certification**

This training is for adults who work in Law Enforcement and Public Safety (law enforcement officers, private security, probation and parole, fire/EMS, corrections, dispatchers, courts, legal, town watch, etc.). For a number of reasons, individuals experiencing mental illness and substance use disorders often have more contact with the criminal justice system than the general population does. Thus, the better prepared officers and staff is to respond effectively and appropriately, the more likely the interaction will be a positive one. Mental Health First Aid offers a tailored supplement which builds upon the effectiveness of the standard Mental Health

First Aid curriculum by focusing on the unique experiences and needs of law enforcement, corrections, and public safety audiences.

Mental Health First Aid for Public Safety is specially designed for police officers, first responders, corrections officers and other public safety professionals, helping them to better understand mental illnesses and addictions. Mental Health First Aid/Public Safety teaches effective response options to deescalate incidents without compromising safety.

### **Veterans and Military Families**

Certification Mental Health First Aid for Veterans is a course specially designed for veterans, family members of veterans, and personnel working with the military and families who want to learn how to help a veteran who may be experiencing a mental health related crisis or problem. Family members and personnel working with military and families are often not aware of how to engage veterans with mental illnesses and addictions. In addition to the impact of military service on the veteran, each has a circle of family (significant other, children, parents, siblings, etc.) and friends who are also impacted by their military service. Mental Health First Aid is a valuable resource that can make a difference in the lives of the more than 22 million veterans, their families, and the communities they live in.

### **Higher Education Certification**

Mental illnesses and substance use challenges often present during adolescence and young adulthood, when many individuals are students at colleges and universities. College and university faculty, staff, families and students can learn how to help each other within a framework of their unique culture and set of resources. Mental Health First Aid offers a tailored supplement which builds upon the effectiveness of the standard Mental Health First Aid curriculum by focusing on higher education settings. This supplement is intended to blend with the existing 8-hour adult / “core” MHFA course and is not appropriate for use with the youth MHFA curriculum.

### **Older Adults**

Mental illness and aging can often be a double stigma. According to the National Council on Aging, the number of Americans 85 and older will triple by the year 2050. Older adults and care partners are less likely to identify a problem as a symptom of a mental health disorder. Furthermore, older adults have high rates of late onset mental health disorders (anxiety/depression) and low rates of identification and treatment. This curriculum module will help existing Adult MHFA Instructors in good standing reach this population with updated prevalence data, a new film, and scenarios.
