Old Business:

1. Artist Circle – postponed indefinitely due to the Covid-19 health crises.

New Business:

- 1. Hon. Daria Hardman opened the meeting by say that the May 04 meeting with elected officials had a great turnout.
 - a. It was particularly important to hear from Congressman Adriano Espaillat regarding his 5 bucket plan. Bucket \$4 The Arts
 - b. There event was also recorded and can be made available.
- 2. Hon. Harriet Rosebud
 - a. Emphasized the importance to focus on the individual artist and the small businesses. There is a critical need to address this group which seems to be missing out on funding and information.

- 3. Cathleen Campbell discussed the process of creating a video on the artists of northern Manhattan.
 - a. Lower Manhattan Arts Council received funding for individual artists and one of the funds made it to artists in northern Manhattan.
- 4. Discussion pertaining to the proposed video on West Harlem artists;
 - a. "Gathering the Voices" of individual artists (2-10) and their experiences should be featured in the video (Hon. Harriet Rosebud)
 - b. Video a possible bridge to other organizations, next step (Cathleen Campbell)
 - i. Include data on the lack of funding to artists in northern Manhattan.
 - c. Some issues to articulate:
 - i. Is this person likely to get loans (inconsistent record keeping, etc.)?
 - ii. What it is like for the individual artists?
 - iii. Should the artist in the video be an actor, directed, or tell their story simply?
 - iv. Perhaps craft 5 questions (Hon. Daria Hardman) and who, ID artists?
 - v. Perhaps 2 min for individual expression?
 - vi. What is the length of the video? (Cathleen Campbell)
 - vii. 2 ½ minutes (Hon. Harriet Rosebud)
 - viii. We need to figure out format and get artists perhaps can have video proto-type by end of the week. (Cathleen Campbell)
 - d. Set up date to exchange ideas and come up with opening questions for the video. (Hon. Daria Hardman)
 - i. One week June 8th. (Hon. Harriet Rosebud) (Hon. Daria Hardman) have questions prepared.
 - ii. 10 seconds of experience mixed with broad data.
 - iii. Tell the real story People do not know the real story. (Hon. Harriet Rosebud)
 - iv. Prepare trailer intro. to be completed by the time the Executive Committee meets.
 - v. Select 2 artists (Hon. Harriet Rosebud & Hon. Daria Hardman)
 - vi. Week of June 8th produce trailer for 6/11 Executive Committee meeting.
- 5. Letter writing campaign
 - a. Campaign to have individual artists write letters, to raise awareness of the need to fund individual artists, to their elected officials.
 - i. Question should the letters have more or less structure?
 - b. Engage artists need to speak out.
 - c. Origin of idea the business community, business model, collect letters to demonstrate that artists represent more than one vote. (Hon. Harriet Rosebud)
 - d. Perhaps to create a template for the artists to follow? (Hon.Walter Alexander)
 - e. Try to consolidate efforts letters & video ? (Hon. Jonathan Sinagub)

- f. Compile 40 letters make 40 copies to present to elected officials (Cathleen Campbell)
- g. Money should go to individual artists (Hon. Daria Hardman)
 - i. How do you get the money to the individual artists? How do they get paid? What is the vehicle to get the money to the individual artist?
 - ii. Set up an art alliance (Cathleen Campbell)
 - 1. % + to go to the artist
 - 2. Alliance/local organization as a pass through to the artist
 - 3. Existing organizations: Northern Manhattan Art Alliance, Columbia University, NYU – Stern, MBA types?
