- Meeting began at 6:35 PM. Roll call was taken by Secretary Kovaleff. A quorum was established. The agenda was adopted.

- CB9 received many inquiries about 1727 Amsterdam Avenue
- Representatives from Health and Hospitals Corp. (Deborah Brown) and Emma Bowen Community Service Center (Patricia Jordan and Tom Haggerty) attended the meeting.
- Patricia Jordan from the Emma Bowen Center gave a summary.
 - The Bowen Center has been located there for 35 years. The critical need is to continue providing services in the same location
- Funding for relocation has been secured with help from the Borough President's Office.
- Proposed redevelopment by Health and Hospitals Corp. and BRC (new building with 200 units of affordable and supportive housing)
- The Bowen Center will temporarily relocate to 520 West 135th Street (old HRA building) between Amsterdam and Broadway.
- The Bowen Center began talks with Health and Hospitals in 2019 prior to the start of the pandemic.
- The Bowen Center is one of the tenants of the current site.
- There has not been provider attrition according to Patricia Jordan.
- What will happen to the other practices? Eye clinic, dental clinic, and other services.
- Was a community health assessment or health impact done prior to the proposed redevelopment?
- Able House (supportive housing for Bowen Center patients), 20-bed facility in East Harlem - only off-site facility
- CB9 is asking for a list of supportive and wrap-around services that the Bowen Center provides.
- Deborah Brown Exec. VP of External Affairs for HHC, Maidel De La Cruz
 Senior Director at HHC, and Miguel Guadalupe Director of Community
 Engagement at BRC would like to come back and give a detailed
 presentation of the project.

- There is no detailed plan yet. There are no drawings or blueprints. There are tentative plans for a nine-story building with 200 units, 60% will be permanent supportive housing, and 40% affordable housing units (housing lottery). AMI will be below 60%. It will not be a homeless shelter.
- Heritage Health Care (another tenant of the space) plans to move out and stay in the district. There has not been very much engagement.
- What is the current square footage for Medical Services today? What is the proposed square footage for Medical Services in the newly developed space?
