Meeting called to attention at 6:44pm.

Chair's Report

Moment of silence for Tessa Majors, Barnard student murdered in Morningside Park. Community board working with 26th Precinct and DA and monitoring investigation because past high profile cases have led to scapegoating. Suspects include teenage boys. Some inaccuracies in media sourced to police. One suspect apparently interviewed without representation. Important to search for truth, not blame or retribution. Need for mental health resources provided to serve youth in area, and take action to heal. MBPO published editorial calling out cuts to after-school and weekend youth development programs. Don't believe everything you read in fast-moving reporting.

New criminal justice reforms passed in Albany this year take effect January 1. Make sure neighbors and others in the community know that.

Overcrowding in schools is a major issue despite reports of under-enrollment from DOE. Thanks to YEL co-chairs and committee for ongoing work.

Applications to CB9, including renewal for members whose terms are expiring, are open and due in January.
