#### **Presentations**

## Darlene Bruce, AM Taylor's Office

Report on the state of HDFCs in 71st AD. Program created to allow residents to invest in their communities to preserve their housing and become homeowners. Predatory lending adding to burden of homeowners, leading to eviction notices. Succession also complicated even when children and grandchildren properly included in homeowners' wills.

Solutions needed across government: draft legislation would give agencies authority to enforce shareholder and tenant rights.

# Taylon Murphy and Derrick Haynes, Credible Messengers

Family members murdered in Grant and Manhattanville Houses, which are sometimes in conflict with each other. Uses CB9 office as neutral space to talk to young people. Important for young people to be able to express themselves.

Embarking on reentry program for those jailed in 2014 raids to promote peace "from the inside out" -- starting by meeting with incarcerated individuals, their families, and influential people in the community. Help heal trauma resulting from law enforcement actions. Model can be replicated elsewhere.

Meeting called to order at 7:17 PM. Meeting agenda adopted unanimously. Minutes adopted unanimously.

### Chair's Report, BW

Board has submitted budget priorities to city OMB to incorporate into mayor's budget. Moving forward with initiatives on 12th avenue: small businesses are struggling; street is collapsing; undertaking rehab of Marine Transfer Station.

JTS contributing \$250K to Morningside Heights via New York Community Trust and \$1M in-kind contribution. UTS \$700K to homelessness prevention via Pa'lante, \$400K to Morningside Heights via NYCT, and \$3.9M in-kind.

Exec Cmte met with 26th Precinct regarding Tessa Majors case. Census still hiring - essential for community to be counted. Working with DHS on homeless outreach to offer appropriate transitioning and shelter housing. CB applications are still open.

### Treasurer's Report, AT

Discretionary money from CMs Levine and Perkins available for outreach, forums. Proposals from committees due Jan 31 to Chair, Treasurer, and DM.

In past years, money transferred to fiscal conduit to be spent in next fiscal year, but this year, money needs to be allocated and spent this year. Up to \$1000/committee.

## District Manager, EP

Homeless Outreach Population Estimate overnight on Jan 27. Rep. Espaillat's state of the district address on Jan 30. Plastic bag ban taking effect on March 1, and paper bags will have 5 cent fee (waived for SNAP recipients).

#### WHDC, PWJ

2020 grant applications in education/youth development, workforce/economic development, and community resources available from \$5K to \$25K. Applications due Feb 7, announced April 2020. WHDC-funded project in Marcus Garvey Village appeared in NY1 segment on problems at work site. Project will have community space for artists. Annual board meeting on Jan 18. Dec 21, 2019 holiday celebration and toy giveaway resounding success.

#### MBPO, AA

CB application deadline extended to Feb 14. Capital funding grants available to non-profit organizations, schools, and cultural institutions, applications due Feb 19. Cultural tourism grants for non-profits and cultural organizations for marketing initiatives, applications due Jan 24.

Partnering with CB9, 26th Precinct, Friends of Morningside Park on community forum following tragedy in Morningside Park at PAL on Jan 29.

Census town hall at Schomburg Center on Jan 30.

Black History Month event on Feb 12 at MIST Harlem, remembering Toni Morrison and celebrating 100th anniversary of Harlem Renaissance.
