Presentation/Update

Update on DSRIP funding given by Arthur Gianelli, [President, Mt. Sinai St. Luke's] and Edwidge Thomas [Medical Director Mt Sinai Health System]

The performing provider Health System is designed to improve services under the 1115 waiver. It allows the Hospital to keep the savings it achieved provided it reinvest them to reduce hospital costs. It netted MT Sinai \$200M. It also partners with meal providers, targets asthma related complications. It also helps people find work.

The programs are rethinking the delivery system; more and more primary care is home based.

Working with faith-based orgs to get the word out.

Martin is leading a bike ride this upcoming Saturday morning as a fundraiser for his son's school starting at West 90th Street and Riverside Drive and celebration of his healed broken leg. The route is the entire outline of Manhattan.

Alicia Barksdale, 3333 Broadway

3333 Broadway has senior classes, including Medicare 101, taxes, and elder abuse. Dates will be available with the board.

ARISE SYEEP had 250 applicants, and 150 were accepted and placed in summer worksites, including Columbia, CB9 and CB10, and various elected officials' offices.

On August 10, 1pm-4pm the youth board will have a March for Our Lives Rally in St. Nicholas Park to

address gun violence, suicide, mental illness, and gangs in the area, including a panel to ask questions of government officials.

Brad Taylor, President of Friends of Morningside Park

Commend the Parks Committee for documenting the Harlem Eat Up festival. Friends of Morningside Park has come to the conclusion that the festival does not need to be in that park. Most of the businesses are in Central Harlem. The most appropriate venue would be one that is paved so tents would cause minimal damage, rather than the torn up lawns that the park has suffered.

Maritta Dunn

MTP Investment Group has expressed an interest in developing the Marine Transfer Station, which has the opportunity to be an important economic venture in our area. The Department of Sanitation has not been accommodating to allow visitors to the site but the prospective investors would like to visit. MTP were interested in the original development of West Harlem Piers, and were not selected, but they are familiar with the area.

The State of Illinois has made President Obama's birthday, August 4, a state holiday. Maritta would like for it to become a state holiday in the State of New York as part of a larger effort to make it a national holiday.

Ken Miles, CB9 rep to the 125th Street BID

The Healthy Clean Harlem initiative of the 125th street BID was a success on June 1. They are trying to continue the conversation around how to get folks involved in cleaning up throughout the year since not everyone was able to participate on the day of that event. They are looking at other dates to get people together over the next couple of months to clean their blocks.

Ken also shared that the expansion of the 2nd Avenue Subway, which is planned to have its final stop at 125th and Park Avenue to meet Metro North, will actually require further construction to Lenox Avenue including ventilation shafts to the surface to allow the trains to turn around.
