- Hybrid Meeting Law will end in September 2022.
- Gov. Hochul will not extend the executive order.
- Mayor Adams has not indicated if he will extend the order.
- Board members should assume they have to meet in person for committee meetings and board meetings.

- Monkeypox virus update
- Polio update
- Bx19 bus stop has been restored on West 145th Street.
- Sen. Robert Jackson is no longer representing our district due to the new redistricting map.
- Refugees being sent to NYC from the Southern Border (Texas)
- 1727 Amsterdam Avenue Update
 - Move out for existing tenants is March 2023
 - Reps joined the Exec. Board Meeting last week
 - HHC and BRC plan to build a nine-story building with 200 units (of supportive housing and affordable housing)
 - Board believes City owns the land and is subject to the ULURP process
 - HHC believes they do and are only subject to hearings and city council votes.
 - G. Morgan Thomas raises concerns about supportive housing in the area and feels that consistent follow-up with inhabitants by providers is not being done.
 - M. Aristy-Farer raises concerns about BRCs projects downtown. Also, there is another supportive housing project one block away. In addition, there is a school with 1,200 kids close by.
 - The health committee and the Housing & Land-use committee are monitoring the situation.

 - Treated as political pawns by Texas and Florida
 - Federal Government needs to support NYC

 - Need legal and translation assistance

 - Drop off at Northern Manhattan Office
 - The request for donations has specifically been new toiletries and hygiene items such as body washes, toothbrushes, menstrual products, new and packaged clothing, and diapers.
