- Department of Sanitation (David Greg) Update on Trash Containerization Pilot
 - an information session will be held next week.
 - Disappointment about the engagement of the rollout. Public was not notified in a timely manner.
- A lot of people have signed up for the public session.
 - Mr. Duval works at the school on 134th Street and Broadway and thinks the pilot at the schools
 - Corey Ortega (Assembly District Leader) just took oath of office. He would like to express that we (as a community) need to give the pilot a shot.
 - Carl Mahanie in favor of the pilot program
 - Neighbors for a Greener Harlem Team Up 2 Clean Up Harlem event in October
 - WeACT strong support of the pilot containerization project. Would like DSNY to provide the community a forum to provide feedback on the program.
 - Eric Schultz from 320 Riverside Drive (104th St) in favor of the pilot program
 - Leila Rojo in favor of the pilot program.
 - Joyce Bialik (NYC Sanitation Equity Coalition) Northern Manhattan has less services than the rest of the island. In favor of the pilot program. Ask that all containers be updated to "all waste streams" containers to promote recycling and composting
