	MPV (Monkeypox): 2 nd dose for MPV vaccines available. At least 28 days prior to 1 st
	dose. Walk-ins are available at City run sites, but appointments are preferred. Check
	out <u>Vaccine Finder</u> , call 311, or at the Tremont Neighborhood Health Action Center
	(1826 Arthur Avenue Bronx NY 10457). There is no cost for MPV vaccines
	• COVID-19: Moderna and Pfizer Bivalent boosters' vaccines are available for 6 months-4 yrs. and all those who are eligible to receive them. Although the mask mandate has
	been lifted, we urge the community to get vaccinated. Booster depends on your
	health status: immune compromise, BMI, and at personal risk. Check out

	Polio: No cases reported however according to Wastewater Surveillance there are
	residuals of Polio in Long Island and New York City. We encourage parents to vaccinate

their children. It's a series of four doses starting at 6 months of age until 5 years. There is a Governor's emergency plan that makes the vaccine available at pharmacies. Schools require children to be vaccinated in Polio.

• We need to meet our community where they are. We can learn from COVID-19 vaccine vans to increase vaccine rates in Polio, flu, and COVID-19, as well as others.

- How can we communicate with our district? For example, for routinized vaccines (infancy to adulthood) vaccine literacy must provide cultural components and scientific design. Messaging around lifetime vaccines. Vaccine education-helping people get information to make their own decisions.
- Create a map that shows where can vaccines be obtained at a free or low cost. Integrate health messaging
- Outreach vans to expand for vaccines on the spot, can NYCHA be utilized? Create availability and increase hours of operation.
- Create spaces where we can have a consensus around the intersection of the work that has to be conducted, we need to work together to build trust and community leaders.
