**MTA- Mr. Alberto Roldan spoke on the roll out of the New OMNY card which will replace the Metro Card. OMNY cards can be bought at all local subway stations. If you are already enrolled in the system for a reduced card you can switch to the OMNY card only after you have used all the money off you Metro Card. You cannot transfer money from your Metro Card to the OMNY card.**
