**There have been several complaints along 1456<sup>th</sup> street along Broadway to Amsterdam Avenue, where I in the last 3 months there have been 20 arrest. 146<sup>th</sup> street has a big narcotic problem and is under investigation for narcotics.**

**Officer Stumer also spoke on the illegal cannabis shops that keep popping up. MYPD has no jurisdiction on the illegal shops. The Marshall Office is handling these illegal shops.**

**The New York City Council is holding hearing on illegal unlicensed cannabis shops.**

**Montefiore Plaza needs to be cleaned up, these are products that have been stolen from the various drug stores and now are being sold. 2 Police Office has been placed on foot patrol to monitor the plaza.**

**DOT Lyle Blackwood spoke on Milling season which starts in March. If there are any locations that is needed for milling please call DOT.**

**Mr. Blackwood stated as far as the Columbia Shuttle Bus and signage for the bus, Columbia will have to reach out to MTA for the signage,**
