

UST COMMITTEE MEETING MINUTES Thursday, June 5th, 2025 6:30 P.M. (In-Person & Virtual)

I. Attendance

II. Call to Order

- The meeting was called to attention at 6:35 PM by S. Prophete
- The meeting was called to order at 7:28 PM by S. Prophete once quorum was achieved and MTA presentation completed.

III. Adopt Agenda

• The motion to adopt the agenda was made by F. Castillo. Seconded by V. Caughman. The agenda was adopted by the members present.

IV. Adopt Minutes (from 05/01/2025 meeting):

• The motion to adopt the minutes from the 05/01/2025 committee meeting was made by F. Castillo and seconded by C. Johnson. Minutes adopted by members present.

V. Presentations/Updates:

• 116th Street Bus & Pedestrian Priority Project (DOT/MTA Update)

1. Introduction & Background

- The project targets improving bus transit and pedestrian safety along a key corridor connecting Harlem and the Upper West Side, roughly spanning Manhattan Avenue (110th–113th St) and Morningside Avenue (113th–114th St) within CB9's jurisdiction.
- This corridor serves **over 40,000 daily bus passengers** via routes including M3, M7, and M116, offering vital crosstown access to destinations like Columbia University, Morningside Park, and St. John the Divine.

2. Existing Conditions

• **Bus Speeds & Reliability:** Buses travel below **4 mph** on some segments due to congestion and double-parking, leading to significant delays.

• Safety Concerns (2020–2024):

Total injuries: 37

o Severe injuries: 4

o Fatalities: 1

• Breakdown: Pedestrians (10), Bicyclists (10), Motor Vehicle occupants (16)

• Demographics & Health:

- o Local asthma, diabetes, and heart disease rates are elevated due to pollution.

3. Public Outreach & Feedback

Participants expressed support and concerns regarding:

- Pedestrianizing the Morningside Avenue slip lane
- Installing concrete pedestrian refuge islands and daylighting
- Addressing double parking during weekend farmers' markets
- Shorter crossings at Morningside Ave & 116th St with **hardened pedestrian space** and bike racks
- Enhanced **enforcement** using DOT stationary cameras and MTA ACE bus cameras in coordination with NYPD

4. Proposed Design Elements

A. Pedestrian Space Enhancements

- Slip lane conversion into pedestrian plaza for potential programming
- Concrete pedestrian refuge islands (e.g., bolstered with bollards, trees)

• Painted curb extension at Morningside Ave & 116th St reducing crosswalk length by up to 39%

B. Bus Priority Measures

• Curbside bus lanes over ~3 blocks on Manhattan Ave, operational Monday–Friday, 7 am–7 pm, reverting to parking at other times New York City Government

C. Bus Stop Consolidation

• Removal of a closely spaced bus stop at Manhattan Ave/112th St (under 750 ft spacing), enhancing bus speed and yielding **>5 new parking spaces** overnight/weekends

5. Curb Regulation & Streetscape Modifications

- Repurposing ~25 parking spaces during weekday daytime for bus lanes; five parking spaces added at the removed bus stop site
- Slip lane converted entirely for pedestrian use on Morningside Avenue
- At Morningside & 116th, ~3 parking spaces replaced with **daylighted curb extension** featuring bike corral provisions

6. Pedestrian Benefits

- Creation of 8,600+ ft² painted pedestrian space and 880+ ft² of concrete pedestrian realm
- One new plaza (former slip lane)
- Two new tree pits enhance streetscape
- **Signal simplification** yields faster traffic flow: Manhattan Avenue NB/SB cycle green time improved by **22 seconds** per 90-second cycle

7. Project Summary & Impact

• **Bus lanes added:** 0.15 miles

• Painted pedestrian space: 9,800+ ft²

• Concrete pedestrian space: 880+ ft²

• New pedestrian plaza: 1 (slip lane)

- New tree pits: 2+
- Estimated parking reconfiguration, signal efficiency improvement; overall enhancing safety and transit efficiency.

8. Implementation Timeline

- 2021: Corridor identified under NYC Streets Plan
- Feb-Mar 2025: Existing conditions discussions with CB9, CB10, and CB11
- May 2025: Draft proposals presented to CB10 & CB11
- June 2025: DOT's draft presented to CB9
- Summer 2025 (Tentative): Begin engineering review, approval, and implementation

Summary

This project aims to vastly improve **transit efficiency** and **pedestrian safety** through infrastructure interventions, disciplined regulation, and streetscape enhancements — all intended to transform 116th Street into a safer, more reliable, and community-friendly corridor.

- NYPD 26th Precinct (P.O. Cardenas)
 - Unable to join today's meeting

 - o Capt. Lopez attended on behalf of Commanding Officer Capt. Rose
 - Summer months historically show an increase in crime
 - In May 2025 alone 14 arrests, 22 summons issued
 - Increase in foot patrols all around the district
 - Stay vigilant call 911 for emergencies, call 311 for quality of life issues
 - 4th of July is very intense in the district
 - Manhattan North supervised by Borough Chief was CO of the 30th and knows the type of resources needed
 - Working with other City Agencies (Parks, DOT, MTA) to address issues at Montefiore Park (137th Broadway)
 - increase space between benches and subway entrance
 - increase lighting
 - ensure the space is cleaned
 - Issues brought up by community attendees
 - Scaffolding
 - Attracting people to loiter underneath
 - Playing of loud music cannot sleep through the night

- Fireworks
- Illegal Vans/trucks selling Marijuana
 - Sheriff's dept. Issuing fines and towing vehicles
 - Violators are paying the fines and get back onto the street
- Illegally parked cars and people loitering in the street playing loud music, smoking and drinking alcohol
 - We need to see more enforcement
 - Limited access to tow trucks
- Roving packs of motor bikes
- Open Drug sales on 144th Street between Broadway & Amsterdam
- NCOs are working with Sanitation to address the issues
- Issues with Bless Bar and Restaurant
- May 14th Billiards location was issued 4 violations/summons
 - No 311 calls since the operation
- o 30th Precinct Community Council occurs the last Thursday of the month
- NYPD PSA6 Housing Division (P.O. Ettienne & Detective Wilbourn)
 - Community Council Meeting 2nd Thursday of the Month meets at PSA6
 - Fellowship breakfast at the Polo Grounds tomorrow
 - o 1 robbery at Grant Houses
 - o 2 felony assaults (Grant/Manhattanville)
 - o 2 burglaries at Manhattanville
 - o 1 grand larceny at Grant Houses
 - No increase in quads or bikes reported in the area
- NYC DOT (Lyle Blackwood)
 - Milling and Resurfacing taking place in the district and Northern Manhattan will be back in mid-July. Will notify District Office
 - Summer Streets will take place in August
 - Capital improvement project at 155th Street new expected completed date in Spring 2026
 - Juan and Felipe brought up large potholes and deteriorating concrete pad at former bus stop on Convent Avenue on 144th and 145th Street
 - Crosswalk from Hamilton Terrace to Hamilton Grange
 - No update, Lyle will follow up
 - o Lighting issues are on their radar
