There was a quorum present.

DOT: Josh Orzeck – Presented measures to improve safety conditions on Broadway at the intersection of West 135<sup>th</sup> Street and West 152<sup>nd</sup> Street. On February 6, 2013 a crash @ West 135<sup>th</sup> Street resulted in a fatality and several related injuries, and at 152<sup>nd</sup> Street there have been four pedestrian injuries and one motor vehicle occupant injury in the first five months according to the data.

There were several discussion regarding Buses on the West Side Highway, these buses are going North bound and South bound. Buses are not permitted on the West Side Highway, as well as Academy buses.

Mr. Ramon Diaz of Floridita Restaurant came before the committee to request that he has a parking problem in front of his restaurant. Mr. Diaz would like to have meter parking from 8am to 6pm. Josh Orzeck from DOT suggested Muni Meters on 12<sup>th</sup> Avenue, he would check to see the availability of the Muni Meters.

A Reso will go before the Executive Committee for the 8am to 6pm meters. DOT will then do a study of St. Clair and 12<sup>th</sup> Avenue and 125<sup>th</sup> Street marginal & 12<sup>th</sup> Avenue

The subject of the M60 Bus came up and Josh stated that DOT did not get the support needed by the community and the Elected Officials.

26<sup>th</sup> Precinct – Officer Deolve gave his report stating that there had been homicide of a Black male at 123<sup>rd</sup> St. Nicholas Avenue which was drug related. There were 2 restaurants renewal, V& T Restaurant located at 1024 Amsterdam Avenue and the other LE Monde. Both were approved with a vote of 3-0-0 for V&T and 3-0-0 for LE Monde. Stats Attached.
