Community Board 9 - Senior Issues Committee Meeting Minutes

Meeting was called to order by the chair, Rev. Georgiette Morgan-Thomas at approximately 11:36 AM.

Agenda and Minutes from the March meeting were adopted unanimously.

Presentation: Adult Day Care program at Amsterdam House

Jay Virella, director of the Adult Day Care program and Theraputic Activities program at Amsterdam House, presents.

This program, based at West 113th st. and Amsterdam, is run on the medical model. It provides activities: social, current events, exercise, trips, (Lincoln Center, Casinos, Movies, Parks) arts and crafts; Transit – to and from home; Medication (two nurses on staff), rides to appointments; education programming (dieticians, related to health issues and diet); Breakfast and Lunch are included plus take home food at the end of the day; vital signs check on arrival.

Because it is all in one building, patients who are in the nursing home or short term rehab can take part in the program and any one in the Adult Day Care who needs rehab can also get the care at Amsterdam House if the space is available.

Religious services are held on the weekends - nondenominational.

Program is open to all who qualify – Medicare, etc. Social worker is on hand to help.

Many participants have home health aides – they can work with your schedule. Program is 7 days a week. Minimum of 5 hours each day.

Mr. Virela asks that we help spread the word about this program.

Ms. Verna from DFTA asked about therapy:

J.V: We provide Occupational Therapy, Physical Therapy and Speech Therapy, even if you are not staying at Amsterdam House

Chair has concerns because of the case from years ago when a senior she knows needed more assistance but Amsterdam House would not accommodate her. What makes accessibility better now?

J.V: 'Not on my watch'. Reason he is director is to improve the program and because new leadership was needed. As director of both in house and Adult Day Care programming, JV works very close with Admin and Nurses.

We are a very successful nursing home with a waiting list. If no beds are available, we can't admit patients, but will do all possible to make sure that participants who qualify will get what they need.

Notes that we are seeing more rehab residents and fewer long term residents due to better health of aging population. Amst. House now has three floors for Short term rehab, up from 1 floor 6 years ago.

Chair: Is there way to prepare participant who is showing signs of deteriorating health. Health tracking?

JV: We pay attention to details. Have planning meetings every Wed., team communicates with each other and family. Ex. Of patient who wanted to reduce frequency of participation. Felt uncomfortable when begin changed (paraplegic). Spoke with family and, once situation was understood, returned to full schedule. Emphasized that they also prepare patients for returning home through education: diet, medical, etc.

Current number of participants = 80

Staff: 1 Social worker, 5 Certified Nurse Aides, 2 RN's (1 is a clinical manager), 3 activity leaders, 1 secretary – handles transportation logistics and scheduling, and Security Guards.

Anthony F.: Criteria for admittance? Insurance, private pay (\$200/day), Medicade, Guild Net, HMO's, DNS.

Seniors can participate on floating schedule with advance notice. Work out with insurance company through Social Worker. No same day participation. Can switch days but must be authorized.

Chair: Flexible days? Yes, but calendar is set through July, so need to plan in advance.

JV: Credentials: Bachelor and Masters in Education – History Degree.

Member: What if I go on vacation and I want my mother to stay at Amsterdam House? JV: Not sure, but will look into it.

Ms. Gilmore: How to alleviate negative attitude towards Nursing homes in general? JV: Very personal – ours is an excellent facility in comparison to others: One of few Not for Profits that survives, Amst House is rated 5 stars, Dept of Health has rated it deficiency free. Positive reviews by patients. Is a JACO skilled nursing facility. Has its own Gym and Geri Gym. Available to seniors who participate in the program.

Ms. Gilmore: How Can I recommend this? Can my friend's daughter come visit? IV: Once a week there is a special open house.

Ann B: What is your catchment area? JV: Bronx, Brooklyn, Yonkers, Queens, LES.

Chair: Is there an Assisted Living Program? JV: No longer: Harborside in Long Island.

Members: I visited 3 different people on 3 different floors. All were comfortable. I am very impressed. My sister was involved in program – very helpful. My church delivers dinners on Thanksgiving and Christmas to church members at Amst. House.

Ms. Prince: Can our committee tour Amst. House?

JV Call to schedule an open house. Anthony: Set aside date – it is our responsibility to our constituents. Can we do groups? JV Max of 10 per tour. Chair: Let's schedule two dates. Anthony: Meaningful for those of us who were critical of previous admin. Want to be supportive of what you do.

Chair: Funding. Seed funds from developers in area to give scholarships to those who do not qualify. Medicare is no help. Many are stuck in the middle. Disparity exists between services provided for Medicare and Medicaid recipients.

The Enclave – St. John's. Ask developers to donate!

JV: Notes that Enclave was supposed to be for Amst. House – handshake agreement – but at last minute St. John's gave it to someone else.

Second Presentation - Goddard Riverside Single Stop Program - Ron Guy

Ron Guy's first experience with community boards was with CB9. Introduces Nancy Castillo – senior specialist with program Located at 140th and Broadway – 9 years at current location Services Available:
