1727 Amsterdam Ave. - Dept. of City Planning Briefing

The HLUZ Co-Chairs, CB9 1st Vice Chair, several public HULZ members and I met virtually with NYC Dept. of City Planning to discuss the redevelopment plans for 1727 Amsterdam Ave. A major focus of the meeting for us pertain to affordability, additional units for local residents as well as the impact on the surrounding community. As the Universal Land Use Review Process (ULURP) has been implemented the HLUZ committee will be taking the next steps in this process including holding a town hall meeting. Announcements will be forth coming on dates and time of the next steps.

NYC Community Planning Fellowship Program

The Fund for the City of New York will be placing area graduate students with Community Boards throughout the five Boroughs. Several of our Board members and I sat in on an information session to prepare to submit proposals to obtain a University Fellow to work with the Board. The proposals at this point in consideration focus around housing and health in the District.

CB9 Office Telephone System
