Con Edison offers easy tips for insulating homes, saving on bills, and staying safe. Con Ed expects residential heating bills to be about 8.6 percent higher than last year due to higher delivery rates and an increase in natural gas prices.

Con Edison does not control the price of natural gas, and Con Edison makes no profit on the gas it delivers to customers. Con Edison analyzes supply and demand forecasts and uses a variety of buying methods, including short-term and long-term contracts, to get the best gas prices for its customers. Those prices are passed on to customers at cost.

The average residential gas-heating bill from November 2017 to March 2018 will be about \$238 per month, according to the company's projections, up from \$219 last year. That estimate is based on average monthly usage of 170 thermos and assumes normal winter weather.

Con Edison has adequate natural gas supplies for the company's 1.1 million gas customers, approximately 370,000 of whom use gas for home heating in Manhattan, the Bronx, Westchester County, and parts of Queens.

Customers can also save money on heating by using these tips:

• Have a qualified contractor clean and inspect your heating system

- Inspect and clean air ducts and heating vents to ensure adequate air flow and eliminate any loss of heated air
- Insulate hot-water pipes and warm-air ducts that pass through unheated areas
- Clean or replace filters for your hot-air furnace and heat-pump
- Install a programmable or smart thermostat and set it automatically to reduce the temperature at night or when no one is home

Department of Health and Mental Hygiene Reported:

Health Department Released New Flu Vaccination Data and Awareness Campaign: "I Got My Flu Shot...Not the Flu"

At the start of the 2017-2018 flu season, the Health Department announced new flu vaccination data. Influenza is a highly contagious respiratory viral illness that can cause significant illness and death. More New Yorkers die from influenza and pneumonia than from any other infection. In 2015, 2,094 New Yorkers died from influenza and pneumonia, which is a common complication of influenza. About 90 percent of influenza-related deaths are among people aged 65 years and older. For the 2016-17 influenza season, there were 106 influenza-associated pediatric deaths nationally, including six influenza-associated pediatric deaths in New York City.

Influenza activity is usually at its peak from January through March, but it can start as early as November and continue through late spring. It is important to get vaccinated now, before influenza season starts. The Health Department also launched a public awareness campaign, "I Got My Flu Shot...Not the Flu," reminding New Yorkers that the flu vaccine is the best protection against influenza and its terrible symptoms.

Health Department Launches "Asthma Doesn't Have to Stop Your Kids From Being Kids" Campaign

The Health Department recently launched a new multimedia campaign educating parents about the benefits of managing their children's asthma every day. The campaign, "Asthma Doesn't Have to Stop Your Kids from Being Kids," reminds parents to work with their health care provider to create a daily asthma management plan that includes taking medication if needed and working with school staff and caregivers. The ads, in both English and Spanish, are running on TV and social media citywide. In New York City, 13.3 percent (173,660) of children suffer from asthma, and it is the leading cause of in-patient hospital stays for children. The rates of childhood hospitalizations due to asthma are also higher in poorer areas (the Bronx, East and Central Harlem, Central Brooklyn). It also disproportionately affects children of color — the prevalence of asthma among Black children is 22 percent and Latino children is 15 percent, compared to 4 percent among White children. The campaign runs through November 26.

Asthma medication, when used as directed, can prevent most asthma attacks from ever happening. More information on daily and emergency asthma medications, as well as services in

New York City, are available online at nyc.gov/health/asthma and by calling 311 and requesting a free Asthma Action Kit. Once a management plan is established, parents should share it with family members, child care centers and other caregivers. Parents should also ask their child's heath care provider to fill out the Asthma Medication Administration Form (PDF), (MAF) and return it to the school nurse every year.

Department of Sanitation Reported:

Enforcement of Business Recycling Rules Began August 1st Streamlined Rules Will Make Recycling Easier and Consistent Across all Business Types:

Sanitation Commissioner Kathryn Garcia announced as of August 1, 2017, the New York City Department of Sanitation began enforcing business recycling rules that went into effect last year. The rules cover all commercial establishments, and others, that have their garbage and recycling collected by private carters. All businesses must recycle metal, glass, plastic, beverage cartons and paper. Some must also recycle textiles and organic material.

The rules were published in February 2016, became effective August 1, 2016. Whereby a one-year warning period was in effect until August 1, 2017.

Previously, businesses recycled different materials based on their business type. Eliminating the distinction between business types and applying the same rules for all will facilitate greater recycling participation and make recycling easier. In addition, the rules allow for co-collection of recyclables in a single recycling stream by authorized private carters, which will help make commercial recycling easier to manage and can significantly increase diversion of recyclables from landfills.

The Department will deploy enforcement officers and agents to conduct inspections of businesses to determine their compliance with the recycling rules. Rules include requiring proper recycling set up; education and notification of employees and customers what and how to recycle, and source-separation where waste is stored before collection, and at set out.

Over the past year and a half, the Department, along with other city agencies, worked directly with businesses to ensure they were properly notified of the rules. Department of Sanitation conducted more than 10,000 outreach site visits and held nearly 100 trainings. Recycling fines per violation (within a 12-month period), first offense: \$100; second offense: \$200; third offense: \$400.

DSNY LAUNCHES NEW APPOINTMENT SERVICE TO SCHEDULE LARGE BULK PICKUPS WILL ALLOW FOR MORE TIMELY COLLECTIONS:

Sanitation Commissioner Kathryn Garcia announced the official launch of a new and innovative appointment system designed to help DSNY more efficiently collect large non-recyclable bulky items such as sofas, mattresses, and large wooden furniture.

New Yorkers can now arrange for timely bulk pickup appointments online at <u>nyc.gov/bulk</u> or by calling 311.

The new service is designed for items that are larger than four (4) feet by three (3) feet, such as sofas and bulky wooden furniture that can be lifted by two workers and be able to fit inside a Sanitation collection truck.

To find convenient donation centers and non-profit partners, visit nyc.gov/donate.

This service <u>does not</u> apply to items that require special handling, such as air conditioners, refrigerators, TVs, computers, and other electronics. To learn how to properly recycle or dispose of those items, visit <u>nyc.gov/dsny</u> or call 311.

Also, metal, glass and rigid plastic items, including bedframes, patio furniture, and filing cabinets, should still be placed out for recycling collection after 4 p.m. the night before your scheduled recycling day.

Some helpful tips:

- Do not block foot traffic or place items in the street or in front of another property.
- If you have more than six (6) large items for collection, schedule additional appointments.
- Place your large items curbside after 4 pm the night before your appointment.
- Mattresses/box springs should be placed in a plastic bag before setting out at curbside to prevent the spread of bed bugs and avoid a \$100 fine.

DOB Reported: DOB NOW, building owners, design professionals, licensees and homeowners can now create online accounts, making it easier to submit applications, make payments, schedule appointments, check the status of an application, pull permits, and make renewals.

DOB NOW will be released in phases with the following currently in effect:

- Inspections provides online scheduling for virtually all inspections, making it easier to schedule inspection appointments, offer more precise inspection scheduling and improve inspection tracking and notifications. Plus, it improves our service by standardizing our Inspectors' electronic checklists and allowing industry members to certify certain objections electronically, eliminating the cost of re-inspections;
- <u>Build</u>: The online platform for Professional Engineers (P.E.), Registered Architects (R.A.), Licensees, Special Inspectors, Progress Inspectors, Filing Representatives and Owners to submit jobs to the Department of Buildings;

DID YOU KNOW?

Gov. Cuomo signed a law to provide employee paid insurance coverage for the following life event:

- Military Deployment;
- Bonding with a newborn, adopted child and/or foster child;
- Caring for a sick family member

This law takes effect on January 2018, Employers must have that insurance coverage in effect on January 2018. This coverage is for employees who work 20hrs or more a week and 175 days a year. Under the Paid Family Leave Policy, employees can take up to 8 weeks of paid leave in 2018 and 10 weeks in 2019 or 2010. The number of weeks goes up to 12 weeks in 2021.

Employees are able to maintain their health coverage for the duration of the leave. The law also protects employees from retaliation. At the end of the leave, employees will be able to return to their old positions or similar one. For further info. please visit: www.ny.gov/new-york-state-paid-family-leave-how-it-works.

Commercial vehicles are not allowed to park in residential streets for more than 3hrs or overnight. This is unless, they are actively working at a location on the block (i.e. a plumber can park his/her vehicle while making repairs at night on a residential street). In addition, commercial vehicles are not allowed to park or to be stored in driveways in a residential zone.

It is illegal for any person to paste, post, paint, print, mail, or attach or affix by any means whatsoever any handbill, poster, notice, sign advertisement, sticker or other printed material upon any curb, gutter, flagstone, tree, lamppost, awning post, telegraph pole, telephone pole, or similar public items on any street; public utility pole, public garbage bin, bus shelter, bridge, elevated train structure, parking meter, mailbox. There is a rebuttable presumption that the person whose name, telephone number, or other identifying information appears on any handbill, poster, notice, sign, advertisement, sticker, or other printed material shall be deemed a separate violation. Anyone found to have violated this provision, in addition to any penalty imposed, shall also be responsible for the cost of the removal of the unauthorized postings.
