OCTOBER, 2020 DISTRICT MANAGER'S REPORT

Return of Indoor Dining: Governor Cuomo announced that as of September 30, indoor dining in New York City is allowed to resume at a 25% occupancy limit. A team of 400 enforcement personnel has been assembled by the City to ensure compliance. If the infection rate does not increase, restaurants may be allowed to go up to 50% capacity.

In concordance with state guidelines and health procedures, the reopening of indoor dining will proceed as follows:

- Temperature checks will be required at the door for all customers
- A member of each party must provide contact information for tracing, if needed
- No bar services
- Masks must be worn at all times when not seated at a table
- Tables must be six feet apart
- Restaurants close at midnight

These guidelines will be reassessed based on data by November 1 to determine whether the capacity limit will be permitted to increase. Census Extended by Federal Court Order: The counting period for the 2020 Census will continue through October 31 after a federal judge ruled against the Trump administration's order to end the count a month early on September 30, citing evidence that found that ending the count prematurely could jeopardize the accuracy of the data. Officials have also been instructed to hold off on delivering the completed data to the White House until April 2021, rather than the December 31 deadline that the administration tried to shorten the count to meet.

Only with an accurate census count can the CENSUS ensure the federal government will give us our fair share of funding for things like school seats, building and maintaining infrastructure, transit, and emergency services. All area census offices will complete their work by **October 31, 2020**.

Cast Your Absentee Ballot: Mail to a <u>local borough office</u> with a postmark no later than November 3rd; In-person at a <u>local borough office</u> no later than November 3rd by 9pm; In-person at ANY early voting poll site from October 24th to November 1st; In-Person at ANY poll site on November 3rd by 9pm.

EARLY VOTING: The early voting period in New York begins on **Saturday**, **October 24th** and ends on **Sunday**, **November 1st**, with <u>hours varying</u> by day for each county.

DOT Reported: Enterprise will no longer have Carshare spots uptown and they will be replaced with either Zipcar cars in certain locations or standard alternate side parking (ASP) spaces will be given back to the neighborhood.

NYC Emergency Management Reported: Emergency Management reminds New Yorkers that creating an emergency plan is the first step to keeping their families safe during an emergency. While all New Yorkers should create a plan, older adults and individuals with disabilities and/or access and functional needs are particularly vulnerable during emergencies. To highlight the importance of planning for emergencies, NYC Emergency Management hosted an emergency preparedness

virtual panel for older adults on September 29, 2020. Representatives from the NYC Emergency Management Department, NYC Department of Health and Mental Hygiene, NYC Department for the Aging, and Older Adult Technology Services (OATS) participated in the virtual panel, sharing information with older adults on the importance of developing an emergency plan.

NYC Emergency Management works with older adults throughout the year to ensure they have the information necessary to remain safe during an emergency. During the event, the panel shared preparedness tips with older adults including the items to include in their Go Bag as well as steps they can take to develop an emergency plan with their friends and family. Panelists also discussed proactive steps older adults can take as we approach flu season. NYC Emergency Management Commissioner Deanne Criswell was also on hand to deliver remarks. Mayor's Office Reported: Executive Order 148, which sets limitations on event permits through December 31, 2020. The Executive Order limits the types of outdoor events permitted by the Department of Parks and Recreation, the Police Department, and the Street Activity Permit Office in order to minimize crowding, facilitate COVID testing and treatment sites, and to allow for use of streets and parks for recreation, learning and dining. Currently, there are over 475 outdoor learning sites in city parks and streets, in addition to 10,200 Open Restaurants and 79 miles of Open Streets.

Safe, creative arrangements will be made for community celebrations, performances, and activations to continue in the city. Planned events include alternate celebrations for signature events, including the Macy's Thanksgiving Day Parade and New Year's Eve in Times Square, in addition to a spooky walk through the West Village for Halloween, and ceremonial motorcycle procession for Veteran's Day, among other virtual and socially distanced in-person activities.

Recent events permitted by Department of Parks and Recreation and the Street Activity Permit Office include dozens of pop-up music performances by the Philharmonic, a staggered run with NYC Runs, and a musical press conference in Times Square with Arts Hero in addition to hundreds of block parties, athletic events, religious events, health fairs, and cultural performances.

Department of City Planning (DCP) Reported: Executive Director Anita Laremont recently announced a new website, NYC Planning Applicants, that allows small and large property owners to submit preliminary required materials for a land use application online. The portal is the first step towards a paperless land use application filing process, one that will save money, trees and storage space.

Through this website, applicants can file Pre-Application Statements and Reasonable Worst Case Development Scenarios digitally. The former provides preliminary paperwork about a proposed project, marking the start of a potential application. The latter is required for projects that need a more in-depth environmental review. Both documents are among the first items submitted for an application.

In the near future, applicants will be able to digitally submit all other required filings for public review, such as the land use application itself and environmental review documents.

NYC Planning Applicants will replace the paper-based system for filing these documents, both quickening the submission process for applicants and continuing DCP's move towards a greener way of conducting business. Through the website, applicants can manage who can edit their projects by adding or removing team members and sending invitations to collaborate. Improved tracking also helps applicants keep an eye on the progress of their proposals.

FDNY Reported: Fire Prevention Week kicked off on October 4, and the FDNY hosted fire safety events throughout the week in all five boroughs!

ELECTED OFFICIALS REPORT:

Manhattan Borough President Reported: The registration period for the CARES Act's "Economic Impact Payments" of \$1,200 (\$2,400 for couples, and \$500 for each child) closes 10/15 for these categories of taxpayers, who do not normally file returns: Social Security retirement, survivor, disability or Railroad Retirement beneficiaries, or Supplemental Security Income or Veterans Affairs benefit recipients who have qualifying children and did not file a return in 2018 or 2019 OR otherwise did not supply information via the nonfliers tool on the IRS website.

Those who didn't receive payments or who don't submit the information by 10/15, may claim the \$1,200 as a tax credit next year on the 2020 federal income tax return.

- In New York City, rates range from \$225-\$500.
- Most schools will excuse absences for serving as a poll worker.
- You will be on the front lines protecting our democracy in an extremely tenuous election year.
- If you are bilingual, you can assist non-English speakers cast their votes.
- You will ensure that every single American has equal access to the ballot.
