Deception Burglaries (The Scam) Criminals often target elderly victims, and operate during normal business hours (9am-5pm), making them less likely to question the situation. These impersonators us false covers such as; utility companies, delivery companies, and companies such as plumbing or electrical contractors. A common ploy being used is: "A pipe broke down the block and we have to check the water". Once inside, the perpetrator(s) manipulate the distract a victim while pocketing their valuables;

Green Dot Card Scam People are losing thousands of dollars in a phone scam involving Green Dot Money Pak cards. After receiving a call from someone who claims to be collecting the debt from either a Utility Company, the IRS or as a settlement for an auto incident; people are being threatened with the loss of their heat, electric, possible deportation or criminal prosecution.

Three typical scenarios:

IRS Scam – A caller informs the victim that they owe back taxes to the IRS and must make immediate payment with a Green Dot Money-Pak;

Accident Scam – The victim's family member had a car accident and the caller threatens physical violence unless immediate reimbursement is made with a Green Dot Money-Pak;

Utility Scam – Utility companies demand immediate payment by Green Dot Money-Pak or your electricity or gas will be turned off







Sidewalk sheds: a modest proposal.

Sidewalk "Sheds" are a relatively new and necessary safety feature on the streetscape.

While safety is, of course, vitally important, my office hears complaints that sheds go up regardless of whether work is about to begin—and often stay up longer than the work requires. This lack of control has led to at least 9,000 sheds covering city sidewalks last year and creating pockets of blight.

Complaints most often come from retail tenants who have little advance notice or control over the pace of the exterior work, yet have to suffer the consequences of reduced accessibility, visibility and pedestrian traffic to their businesses. Making sure the exteriors of buildings are safe for pedestrians is critical, but reasonable steps need to be taken to make the process fairer for those who rely on pedestrian visibility and building attractiveness to pay their rent.

The Department of Buildings (DOB) has to do better to align the start and end dates of shed permits with the actual exterior work by requiring owners to submit work schedules. The DOB should also be empowered to order removal of sheds after a reasonable period – say, 90 days – unless a satisfactory explanation is provided by an engineer. And tenants should receive 30 days' notice that sheds will be constructed so they may plan accordingly.

Driverless cars: a NYC symposium.

An enormous amount of research and development is going into the development of driverless cars—known as "Autonomous Vehicles" in the industry. It's not a matter of "if" anymore, it's a matter of when. That's why my office is sponsoring a forum with representatives from the city's Taxi & Limousince Commission, Dept. of Transportation, NYU's Rudin Center, and one of the manufacturers of AV's, Audi. It promises to be an interesting discussion—please join us! Tuesday, Sept. 27, 4 – 7 pm, 1 Centre St., 19th Floor South. Please RSVP online at *DriverlessNYC.eventbrite.com*.

Pier 40/St. John's Terminal proposal isn't good enough.

My office has recommended the denial of land use applications and the transfer of air rights from the Hudson River Park Trust for the proposed redevelopment of the St. John's Terminal site in the West Village as part of the city's Uniform Land Use Review Procedure (ULURP).

A worthy plan for the St. John's Terminal site would have more and better affordable units, a true neighborhood retail plan, and accessible public spaces that residents will actually use. We don't need to choose between a massive project with massive flaws and letting Pier 40 fall into the river. The City Planning Commission is now considering the proposal (and held a public hearing on the proposal in late August). After the CPC votes, it will be considered by the City Council. 
